#### **Grounding Policy:**

In the event that an owner grounds the Genesis 24 Boat, defined as the bottom of the Genesis 24 Boat making abrupt contact with a lake bed or sea bed, the Trident Hybrid powertrains warranty is subject to voidance. Grounding poses a risk of damage to the Genesis 24 Boat's components and compromises the integrity of the powertrain system.

Owners must exercise extreme caution when navigating shallow waterways and should plan ahead for tides and other natural factors to avoid grounding incidents.

If an owner grounds the Genesis 24 Boat and requires replacement of a propeller, Genesis Marine Technologies must be promptly notified. Upon notification, Genesis Marine Technologies will dispatch a technician to assess the extent of the damage. The technician will determine whether any of the Trident Hybrid powertrain components have been affected by the grounding incident.

Based on the technician's assessment, Genesis Marine Technologies will make a decision regarding the warranty status as well as a safety determination whether the Genesis 24 Boat is able to be safely operated. While our systems are robust and engineered for durability, any accidental damage caused by the owner or by unknown persons may result in the voidance of the full 5-Year Limited Warranty.
